


Cimarex Energy Co. seeks an order approving a non-standard oil spacing and proration unit (project area) comprised of the S/2S/2 of Section 10, Township 15 South, Fange 31 East, NMPM, to form a non-standard 160-acre oil spacing and proration unit (project area) for any and all formations or pools developed on 40-acre spacing, and pooling all mineral increasts in the lower Abo/Wolfcamp formation underlying the non-standard unit. The unit is to be dedicated to the Antietam 10 Fed. Com. Well No. 2-H, a horizontal well to be drilled at an orthodox surface location in the SE/4SE/4, with a terminus at an orthodox location in the SW/4SW/4, of Section 10.
