McElvain Oil & Gas Properties, Inc. ("McElvain") proposes the re-completion of the Ruby #1 well to test the Fruitland Coal formation under the captioned spacing unit. The surface location for the well is 1,755' FSL and 860' FWL of the section. The total vertical depth of the well will be approximately 1,710'. You are the owner of an estimated  $\frac{1}{8}$  mineral interest under the captioned spacing unit.

Enclosed is an Authority for Expenditure estimating the total drilling and completion cost of the proposed well. Your estimated proportionate share of the total cost of the well is \$ . Please mark the appropriate space and sign below to indicate whether or not you elect to join in the drilling of the well. Please return one copy of this letter to the undersigned using the enclosed postage paid return envelope. Upon receipt of a signed election to participate in the well we will send you an Operating Agreement for your review and execution.

If you do not want to participate in the re-completion of the well, we will consider the acquisition of an oil and gas lease from you on mutually agreeable terms. We respectfully request that you provide us with your election on or before November 10, 2008. After that date, McElvain will proceed with an application to the New Mexico Oil Conservation Commission seeking an order pooling all mineral interests in the spacing unit for the well.
