

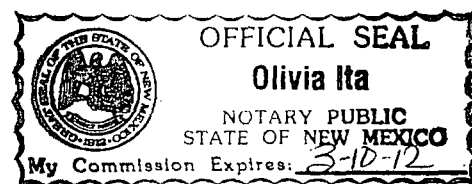



McElvain proposes to re-complete the Ruby Well No. 1 at a location 1755 feet from the South line and 860 feet from the West line to test the Fruitland Coal formation. This well will be dedicated to a 320-acre spacing or proration unit in the Basin Fruitland Coal Gas Pool.

This application has been set for hearing before a Division Examiner at 8:15 a.m. on January 8, 2009. The hearing will be held in Porter Hall in the Oil Conservation Division's Santa Fe Offices located at 1220 South Saint Francis Drive, Santa Fe, New Mexico 87505. Failure to appear at that time and become a party of record will preclude you from challenging the matter at a later date.
