Gentlemen:

Pursuant to the agreement of counsel, this case will be continue from its May 1 setting till some time in June.

I will presumably be the legal examiner, sitting together with a Petroleum Engineer as technical examiner, in this case when it comes to hearing. It will be helpful to the Division for me to participate in this case since I am the only attorney here who, at this point, has extensive experience dealing with Order R-111-P issues. Accordingly, subject to the considerations outlined below, the matter will be re-set at a time when I will be available to participate.

However, I have certain associations with the Fasken organization that could lead to possible arguments that I am disqualified to sit as an examiner in this case, and I am accordingly writing this to disclose those associations to all parties. If the parties are willing to waive any possible disqualification on this basis, I request that they so inform me by response email or letter.

My father, who passed away in 1989, served for many years as a legal and business advisor to David Fasken and

Barbara Fasken, both now deceased, who were predecessors of the present Fasken organization, of which I believe that Barbara Fasken's son is a principal, though the details of the present organization are unknown to me. As a result of this historical association a family partnership of which I am a partner owns interest in a large number of oil and gas properties of which Fasken is the principal, or a principal, owner. Consequently, I have many business dealings with the Fasken organization in my private and personal capacity. However, I own no interest in the well or land that is the subject of this Application. I have no interest in the Fasken organization and will not receive any benefit, nor do I participate with Fasken in any venture in which they are involved except where I am a joint interest partner by reason of ownership derived from conveyances prior to 1989.

Based on the foregoing, I believe that I am clearly not disqualified in this matter by reason of interest. I also believe that I am not disqualified by reason of any bias or prejudice for or against the present Fasken organization. However, I wish to be assured that both parties are comfortable with my participation in this matter.
