1 WHEREUPON, the following proceedings were had at
2 9:05 a.m.:

3 CHAIRMAN WROTENBERY: It's shortly after 9:00
4 a.m., we'll call this meeting to order. This is a hearing
5 of the Oil Conservation Commission. We're meeting in
6 Porter Hall in Santa Fe, New Mexico. I'll note for the
7 record that all three Commissioners are present at this
8 meeting, and we really have just one case to hear today.

9 We do have the minutes of the July 17th, 2003,
10 Commission Hearing. Commissioners, have you had a chance
11 to look at those minutes?

12 COMMISSIONER BAILEY: Yes, I have, and I move
13 that we adopt them.

14 COMMISSIONER LEE: Second.

15 CHAIRMAN WROTENBERY: All in favor say aye.

16 COMMISSIONER BAILEY: Aye.

17 COMMISSIONER LEE: Aye.

18 CHAIRMAN WROTENBERY: Aye. And I'll sign on
19 behalf of the Commission.

20 And then we do have on the agenda for today the
21 Application of the New Mexico Oil Conservation Division
22 through the Environmental Bureau Chief for repeal of Rules
23 18, 105 and 313 and adoption of a new rule regulating pits,
24 and this case is going to be continued, at the request of
25 the Division, until the Commission Hearing on September

1 11th, 2003.

2 We also had a couple of applications, Case
3 13,048, the Application of Devon Energy Production Company,
4 L.P., for compulsory pooling in Lea County, New Mexico and
5 Case 13,049, the Application of EGL Resources, Inc. for
6 compulsory pooling in Lea County, New Mexico. These two
7 cases are being heard *de novo* by the Commission.

8 We did receive a motion to vacate this hearing in
9 those two cases, which motion we granted, and that means
10 that we will be rescheduling the hearing in these cases
11 after the completion of a related Division hearing. That's
12 basically what's at work there. Right Ms. Bada?

13 MS. BADA: Yes.

14 CHAIRMAN WROTENBERY: Okay. So we won't be doing
15 anything further on those today, or until the Division
16 hearing process is completed.
