25 MR. BRUCE: Mr. Examiner, Jim Bruce. On page 1, the

1 first two cases, the Enervest cases, I would ask that they be
2 continued two weeks. We just need to submit some more notice
3 materials, and those things are still coming in.

4 MR. EZEANYIM: Continue it to February 5th?

5 MR. BRUCE: Yes, sir.

6 MR. EZEANYIM: Okay. Let the record reflect that on
7 page 1, Case No. 14242 is continued to February the 5th.

8 Case No. 14243 is continued to February the 5th.

9 Any other continuances or dismissals? Then that
10 leaves us with one case for this hearing.






