APPLICATION OF NEARBURG PRODUCING COMPANY FOR AN EXTENSION OF THE TEMPORARY ABANDONMENT STATUS OF ONE WELL, EDDY COUNTY, NEW MEXICO.

MOTION FOR AN EMERGENCY ORDER

Pursuant to NMAC 19.15.2.12, Nearburg Producing Company ("Nearburg") moves the Division for an emergency order extending the temporary abandonment status of the Parino Well No. 1 from March 16, 2009 to March 31, 2009. In support thereof, Nearburg states:

- 1. Applicant is the operator of the Parino Well No. 1, located 1980 feet from the south line and 660 feet from the east line of Section 23, Township 19 South, Range 25 East, N.M.P.M., Eddy County, New Mexico (API No. 30-015-23049).
- 2. The Parino Well No. 1 is currently temporarily abandoned, but that status terminates on March 16, 2009. Nearburg requested an administrative extension of the temporary abandonment status of the well. However, that request was denied by the Division on February 16, 2009, because the well has been temporarily abandoned for more than five years. **Exhibit A**.
- 3. The Division's letter was received by Nearburg on February 20, 2009, too late to apply for the March 19, 2009 hearing. Therefore, Nearburg filed its application for the March 31, 2009 docket, requesting a one year extension.
- 4. Nearburg requests that an emergency order be issued by the Division, extending the temporary abandonment status of the Parino Well No. 1 until this case can be heard on March 31st. Nearburg asserts that such an order is proper, for the following reasons:

- (a) The Parino Well No. 1 passed an MIT test on October 2, 2008. **Exhibit B** (on file with the Division). Therefore, the well does not present any environmental or other risk, and no harm will result from granting this motion.
- (b) Nearburg has no out-of-compliance wells, and is otherwise in compliance with Division rules and regulations.
- (c) Nearburg has filed an Application for Permit to Drill ("APD") with the Division, proposing a re-entry to test the Glorieta-Yeso formation (Undesignated North Seven Rivers Glorieta-Yeso Pool). A copy of the APD is attached to the Application filed herein. Thus, Nearburg has a plan of operations regarding this well.
- (d) Nearburg has not yet commenced re-entry operations on the Parino Well No. 1 due to decreased oil prices coupled with drilling costs which have only recently started to decline. This uncertainty and price/cost variance should be resolved over the next year.
- 5. As a result, Nearburg requests entry of an emergency order granting a fifteen day extension of the temporary abandonment status of the Parino Well No. 1, through March 31, 2009, so that this case can be heard without placing Nearburg in violation of Division rules and regulations, and making it subject to penalties.

WHEREFORE, Nearburg requests that the Division enter an emergency order approving an extension of the temporary abandonment status of the Parino Well No. 1 from March 16th to March 31st.

Dear Mr. Grant:

I am responding to your letter to Gail MacQuesten of February 9, 2009, requesting a two-year extension of the March 16, 2009 temporary abandonment deadline for the above named well. Your request is being denied for the following reasons.

Oil Conservation Division Rule 19.15.25.12 NMAC provides that the Division may place a well in approved temporary abandonment status for a period of up to five years. This means the Division has the discretion to decide whether to place a well in temporary abandonment and the length of time for temporary abandonment, provided the temporary abandonment does not extend beyond five years.

According to OCD records the well last reported production in July 1997. The well has been temporarily abandoned several times during this time.

You may be able to apply for a hearing on the matter.


