STATEMENT OF THE CASE

The Oil Conservation Commission (OCC) re-opened the record in Case No. 14255 for the limited purpose of the parties submitting a proposed property description by section, township

Case 14255 Pre-hearing Statement Page 1 of 3 and range for that portion of the Galisteo Basin located within Santa Fe County. The Oil Conservation Division (OCD) was required to file its proposed description by March 25, 2009 and provide the proposed description to all parties of record; all other parties were required to file any proposed modifications to the OCD's real property description by April 1, 2009. The OCC has scheduled a hearing on April 15, 2009 to hear testimony from the parties and take public comment on the proposed real property descriptions.

The OCD filed its response and served the parties of record with copies of the response and all attachments by first class mail on March 19, 2009. The response included the OCD's proposed real property description, and maps used in preparing the real property description.

The OCD has not received any proposed modifications to its proposal.




