- 10. <u>CASE 13922 (Reopened and Re-advertised)</u>: Application of Yates Petroleum Corporation to reopen Case No. 13922 to amend Order No. R-12765, Eddy County, New Mexico. Applicant seeks an order re-opening Case No. 13922 for the purpose of amending Order No. R-12765 to correctly reflect the unitized interval in the Recif Unit, Eddy County, New Mexico. Said area is located approximately 13 miles west of Carlsbad, New Mexico.
- 11. <u>CASE 14325</u>: Application of Chesapeake Operating Inc. for approval of a pilot project in the Seven Rivers formation to study the feasibility of implementing enhanced recovery operations in this pool, Lea County, New Mexico. Applicant in the above-styled cause seeks an order authorizing a pilot project on Federal Oil and Gas Lease NM 56749 covering 520 acres located in the W/2, W/2 SE/4, N/2 NE/4, SW/4 NE/4 of Section 14, Township 19 South, Range 33 East, NMPM by the injection of water into the Tonto-Seven Rivers Pool in its Federal USA L Well No. 4 at a location 2100 feet from the South line and 2310 feet from the West line of Section 14, Township 19 South, Range 33 East, NMPM. Said lease is located approximately 13.5 miles South Southeast of Maljamar, New Mexico.

12. <u>CASE 14271</u>: (Continued from the May 14, 2009 Examiner Hearing.) Application of Vanguard, LLC for a Non-Standard Gas Spacing and Proration Unit and an Unorthodox Gas Well Location, Lea County, New Mexico. Vanguard's application in this case has been previously heard. This case is being set for a further hearing to afford respondent, Techsys, Inc., an opportunity to show cause why its W.D. Grimes NCT-A Well No. 4 (API No. 30-025-07522), located 330 feet from the North line and 2310 feet from the West line of Section 32-18S-38E should not be ordered shut-in due to its unorthodox location and the presence of another well completed in the same spacing unit.

13. <u>CASE 14310;</u> (Continued from the April 30, 2009 Examiner Hearing.)

Application of Devon Energy Production Company, L.P. for an exception to NMAC 19.15.15.10.C to allow a second well on a well unit and for an unorthodox gas well location, San Juan County, New Mexico. Applicant seeks approval to re-enter its Northeast Blanco Unit Well No. 321, located 835 feet from the South line and 2475 feet from the East line of Section 18, Township 31 North, Range 6 West, N.M.P.M., and complete it in the Pictured Cliffs formation (Rosa-Pictured Cliffs Gas Pool) as an infill well in an existing 160 acre gas spacing unit comprising the SE/4 of Section 18. Applicant seeks an order pooling all mineral interests from the surface to the base of the Fruitland Coal formation underlying the W/2 of Section 8, Township 29 North, Range 13 West, NMPM, to form a standard 320-acre gas spacing and proration unit for all pools or formations developed on 320 acre spacing within that vertical extent, including the Basin-Fruitland Coal Gas Pool. The unit is to be dedicated to the Airport 29-13-8 Well No. 113, to be located at an orthodox location in the NW/4 NW/4 of Section 8. Also to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation
