

On July 27, 2009 the San Juan 29-5 Unit 6th expansion revised for the Fruitland Coal formation was submitted to our office for approval. The approval for this expansion was accomplished on August 7, 2009. The submission of this expansion caused the following Communitization Agreement (CA) to become obsolete due to the inclusion into the Fruitland Coal participating area.

<u>NMNM-116308, Sec. 9, T29N, R5W, E/2 dedication for San Juan 29-5 Unit #61. Effective 10/8/2002</u>

This agreement communitized particular acres of Federal lands within the San Juan 29-5 Unit as to natural gas and associated liquid hydrocarbons producible from the Fruitland Coal formation. The term of the agreement was for 2 years and for so long thereafter as communitized substances are produced in paying quantities.

Our records indicate that the well dedicated to the described agreements were completed and that the public interest requirements for the communitization agreement, pursuant to 43 CFR 3105.2-3, have been met.

The termination effective date of this CA is November 1, 2002, this date being the effective date of the 6th expansion to the Fruitland Coal formation.
