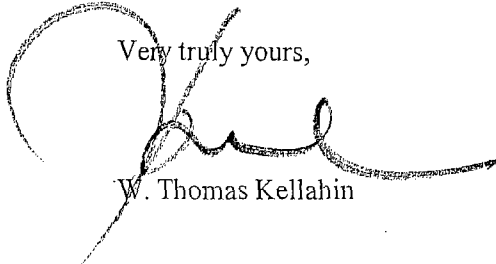
Dear mineral interest owner:
