

IN THE MATTER OF THE APPLICATION OF ENSTOR GRAMA RIDGE STORAGE AND TRANSPORTATION, LLC FOR EXPANSION OF THE GRAMA RIDGE MORROW STORAGE UNIT AND THE AREA SUBJECT TO THE SPECIAL PROJECT RULES AND OPERATING PROCEDURES FOR THIS STORAGE UNIT, LEA COUNTY, NEW MEXICO.

APPLICATION

Enstor Grama Ridge Storage and Transportation, LLC ("Enstor"), through its undersigned attorneys, hereby makes application for an order expanding the Grama Ridge Morrow Storage Unit and the area subject to the Special Rules and Regulations for the Grama Ridge Morrow Storage Unit, and in support of its application, Enstor states:

1. Enstor is the operator of the Grama Ridge Morrow Gas Storage Unit which is used for the purpose of injection, storage, and withdrawal of gas in the unitized formation, consisting of those Morrow formation sands encountered between log depths of 12,722 feet and 13,208 feet in the Shell Oil Company State GRA Well No. 1 (API No. 30-025-21336) located 1980 feet from the North line and 660 feet from the West line (Unit E) of Section 3, Township 22 South, Range 34 East, N.M.P.M. Lea County, New Mexico.

2. The Grama Ridge Morrow unitized area (also known as the Grama Ridge Morrow Gas Storage Agreement Area) was approved by the Division on January 29, 1973, pursuant to Order No. R-4473, and has been subsequently amended to encompass the above-referenced interval of the Morrow Formation underlying the following lands:

Township 21 South, Range 34 East, N.M.P.M.

Sections 33 and 34: All

Township 22 South, Range 34 East, N.M.P.M.

Sections 3 and 4: All

Section 10: All

2. There has been uncertainty concerning the actual limits of the Morrow storage reservoir under these lands and the apparent boundaries between the storage reservoir and the East Grama Ridge-Morrow Pool gas pool is uncertain.

3. As a consequence, there exists a reasonable potential that drilling, completion and operation of new wells, or recompletions of existing wells, in the area would result in interference with Unit Operations and the impairment of Enstor's correlative rights.

4. To protect this unit and the stored Morrow gas located therein, Raptor Natural Pipeline LLC, predecessor operator to Enstor, sought the establishment of Special Project Rules and Operating Procedures for the Grama Ridge Gas Storage Unit Area.

5. By Order No. R-11611, dated July 3, 2001, entered in Cases 12588 and 12441, the Division adopted Special Rules and Regulations for the Morrow Gas Storage Unit that provide for:

- A. advanced notification of drilling or recompletion operations ; ✓
- B. the sharing of certain information during drilling operations ; ✓
- C. availability of well logs ; ✓
- D. certain casing and cementing requirements for wells penetrating the Morrow Formation ; and ✓
- E. a prohibition on completions within the Unitized formation underlying the Unit Project Area by other than the operator.

6. The Special Project Rules and Operating Procedures for the Grama Ridge Morrow Gas Storage Unit do not provide for a buffer zone around the Storage Unit.

7. Current information on the Morrow Gas Storage Unit establishes that this storage reservoir extends into Section 9, Township 22 South, Range 34

East N.M.P.M. and that the Morrow Gas Storage Unit Area should be extended to include this section.

8. By application filed contemporaneously herewith, Enstor seeks to Inject into the this storage reservoir in its Grama Ridge Federal 8817 JV-P Well No. 1 (API No. 30-25-30686)-located 660 feet from the North line and 1980 feet from the East line of said Section 9.


9. Enstor therefore seeks an order an order expanding the Gama Ridge Morrow Storage Unit to include Section 9, Township 22 South, Range 34 East, N.M.P.M., and expansion of the area subject to the Special Rules and Regulations for the Grama Ridge Morrow Storage unit to include this acreage.

10. Approval of this application will be in the best interest of conservation, the prevention of waste and the protection of correlative rights.

11. Notice of this application has been provided to all affected interest owners identified on Exhibit A to this application.

WHEREFORE, Enstor Grama Ridge Storage and Transportation, LLC requests that this application be set for hearing before an examiner of the Oil Conservation Division on June 25, 2009 and that after notice and hearing as required by law and the rules of the Division that this application be approved.
