WHEREUPON, the following proceedings were had at 8:15 a.m.:

EXAMINER STOGNER: This hearing will come to order. Please note today's docket is Docket Number 39-03, and today's date is Thursday, December the 4th, 2003. I'm Michael Stogner, appointed Hearing Officer for today's cases.

At this point I'll go through the known continuances and dismissals.

Let's go to the second page, Case Numbers 8287 and 8288. Both of these are the Application of Bass Enterprises Production Company. Well, let's see, they concern -- both concern the potash. 8287 is for the amendment of Division Order Number R-111-A, Eddy and Lea County, New Mexico; and 8288, was approval of drilling islands and special rules for potash-oil area, Eddy County, New Mexico.

These cases were originally heard and docketed back in the late 1980s, early 1990s, and were continued indefinitely. And in preparing our case files for imaging it was time we did something with these, so I readvertised them and reopened them and notified the parties that this case -- both cases would be dismissed unless the Applicant appeared to show cause why these matters should not be heard. I did get a letter from Bass Enterprises last week.

Both of these matters will be dismissed. So 8287 and 8288 1 are dismissed. 2 Third one, Case Number 13,144, this is the 3 Application of Permian Resources, Inc., for special pool 4 5 rules or, alternatively, for an unorthodox well location, 6 Lea County, New Mexico. This case will be continued to the 7 January 8th, 2004, hearing. 8 Case 13,180 is the Application of Kaiser-Francis 9 Oil Company for pool creation and adoption of special rules and regulations for the new pool -- for a new pool in the 10 11 Paddock oil, Lea County, New Mexico. This case will be 12 dismissed. 13 Case 13,179, this is the Application of 14 Chesapeake Operating, Inc., for compulsory pooling, Lea 15 County, New Mexico. This case will also be dismissed. 16 Page 3, third one down, Case Number 12,681, this 17 is the matter reopened pursuant to Order Number R-11,680. 18 This case will be continued also to January 8th, 2004. 19 Are there any other continuances or dismissals at this time? 20 21 MR. BRUCE: Mr. Examiner, the first page, the 22 fourth case down, 13,184, we request that that case be 23 dismissed. 24 EXAMINER STOGNER: 13,184, this is the Application of Mewbourne Oil Company for an unorthodox gas 25

well location --

MR. BRUCE: Yes, sir.

EXAMINER STOGNER: -- Case 13,184 is dismissed pursuant to Mr. Bruce's request.

MR. OWEN: Mr. Examiner --

EXAMINER STOGNER: Yes.

MR. OWEN: -- on the third page, second case down, 13,177, I'm appearing on behalf of Crossland Operating, L.L.C.

This case was originally heard a month ago, and it has been continued to today's date. It's my understanding that the parties have reached verbal agreement, they're waiting on a written confirmation of those agreements, and I request that it be continued for two weeks accordingly.

In addition, I've had discussions -- a number of discussions about this advertisement. It seeks -- The advertisement seeks pooling of the southeast quarter, northeast quarter. Both the Application and my notice letters accurately reflect that it's the entire east half being pooled in this case, and for the readvertisement for the next hearing, I request that it reflect the accurate -- I'll make the request on the record and follow up with another letter that it reflect what the accurate --

EXAMINER STOGNER: Okay, I believe, if this is to

be readvertised, you've missed the deadline for the December 18th docket.

MR. OWEN: And -- I understand that, and it's been a problem that's been ongoing. I've asked that the advertisement be amended a couple of times, and if it hasn't been done so, I'll follow up with another letter.

EXAMINER STOGNER: Okay, I will look into that.

MR. OWEN: I'm not sure exactly where the problem is. I think it's just a matter of miscommunication between my office and the Division.

EXAMINER STOGNER: If you would, once you're through today, if you would collect any mailings or whatever you have mailed to us for that readvertisement, if you would send that directly to me I'll look into this matter.

Okay, so at this point Case Number 13,177 will be continued to December 18th. I don't know, or I don't have anything in the record here that shows me that the advertisement has been corrected, but if you're going to be here for the rest of the day we can run upstairs and check that out. And at that time, if we need to, we can continue it again for the January 8th, 2004, hearing. So we'll need to check on the readvertisement of this case.

MR. OWEN: I hadn't planned to be here for the rest of the day --
