**STATEMENT OF CASE**

**APPLICANT:**

Applicant in the above-styled cause seeks an order pooling all mineral interests from a depth of 3,350 feet subsurface through the base of the Morrow formation in the following described spacing and proration units located in the S/2 of Section 29, Township 18 South, Range 30 East, N.M.P.M., Eddy County, New Mexico: the S/2 for all formations and/or pools developed on 320-acre spacing which includes but is not necessarily limited to the Undesignated North Turkey Track-Morrow Gas Pool; Undesignated Benson-Strawn Gas Pool; the SE/4 for all formations and/or pools developed on 160-acre spacing; the S/2 SE/4 for all formations and/or pools developed on 80-acre spacing which includes but is not necessarily limited to the Undesignated Santo Nino-Bone Spring Pool; and the SW/4 SE/4 for all formations and/pools developed on 40-acre spacing which includes but is not limited to the North Benson-Queen-Grayburg Pool;

Undesignated South Loco Hills-San Andres Pool; Undesignated South Leo Wolfcamp Pool. Applicant, dedicate these pooled units to its Bradley "29" Federal Com Well No. 1 to be drilled at a standard gas well location 660 feet from the South line and 1980 feet from the East line of said Section 29 to an approximate total depth of 11,800 feet to test any and all formations from a depth of 3,350 feet subsea through the base of the Morrow formation. Also to be considered will be the cost of drilling and completing said well as well as actual operating costs and charges for supervision, designation of applicant as operator of the well and a charge for risk involved in drilling said well.


