ORDER REMANDING TO THE DIVISION

This matter came on for hearing before the Oil Conservation Commission ("Commission") on October 7, 2009 pursuant to the Motion To Remand to the Division filed by Approach Operating LLC, ("Approach"), through its undersigned attorneys, Montgomery and Andrews, P.A., (J. Scott Hall) with the concurrence of the Board of County Commissioners of Rio Arriba County, through their attorney, Adan E. Trujillo. Proposed Intervenor, Dwight E. Rice and Karen Rice, Trustees, Rice Family Living Trust, (together, "Rice"), appeared through their counsel, Steven Sugarman, Esq. The Commission, having heard argument and being duly advised, finds the motion is well taken and ORDERS as follows:

1. The Applications for Permits to Drill ("APDs") that are the subject of Case No. 14134, Case No. 14141 and Case No. 14278 that have not otherwise been withdrawn by Approach are remanded to the Division for disposition in accordance with regular administrative technical review procedure by the Division's District III office. The remanded APDs are for the following proposed wells ("Remanded APDs"):

3. Pursuant to 19.15.14.10 B NMAC of the Division's rules and regulations, all permits that may be issued for any of the Remanded APDs or for any other APDs submitted by Approach for any wells that Approach proposes to drill on its current leasehold in Rio Arriba County shall reflect, without limitation, the following condition: *"Applicant shall comply with all applicable county ordinances."*

4. None of the wells subject to the Remanded APDs are located on or are in close proximity to the lands owned by Rice. However, Approach has volunteered, and hereby is ordered to, through counsel, provide notice to Rice of (a) the submission of the Remanded APDs to the Division's District III office and (b) District III's issuance or denial of a permit for any of the Remanded APDs. Approach shall give such notice to Rice within five business days of such submission, and within 5 business days of its receipt of notice of such issuance or denial. Within 30 days from the date of the issuance

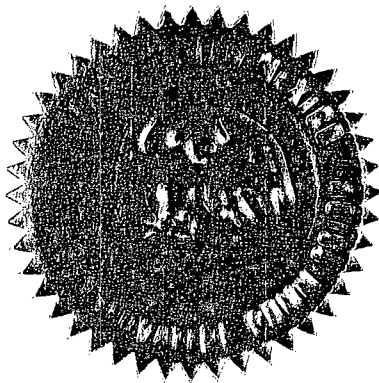
of a permit for any of the Remanded APDs, Rice may file an application for an adjudicatory hearing to review such issuance, pursuant to Rule 19.15.4.8 NMAC.

5. All motions pending as of the date of this Order are moot and are hereby denied, without prejudice to any participant to raise in a future hearing related to this matter any issues and/or arguments addressed in such pending and denied motions.

6. Order No. R-12976 is hereby vacated.

7. Case Nos. 14134, 14141 and 14278 are dismissed.
