2 order. Good morning, everybody. Today we're going to  
3 consider Docket Number 32-09. The usual order of  
4 business is to read all the continuances and dismissals.  
5 Starting on page 1, Case Number 14321 is continued to  
6 November 12th.

7 On page 3, Case Number 14380, continued to  
8 October 15th. Page 4, Case Number 14378 is dismissed;  
9 Case Number 14379 is dismissed; Case Number 14319 is  
10 dismissed; Case Number 14367 is continued to October  
11 15th; Case Number 14381 is continued to October 15th;  
12 Case Number 14382 is continued to October 1.

13 On page 5, Case Number 14282 is continued to  
14 October 1; Case Number 14343 is continued to October 1;  
15 Case Number 14344 is dismissed.

16 Page 6, Case Number 14345 is dismissed; Case  
17 Number 14353 is continued to October 15th; Case Number  
18 14354 is continued to October 15th; Case Number 14173 is  
19 dismissed.

20 Page 7, Case Number 14329 is continued to  
21 October 15th; Case Number 14350 is dismissed; Case Number  
22 14351 is continued to October 1; Case Number 14352 is  
23 continued to October 1. On the last page, Case Number  
24 14373 is continued to October 1; Case Number 14374 is  
25 continued to October 1.

1           At this point are there any other continuances  
2 or dismissals? This is how I think we are going to go  
3 today. We are going to do the order of the remaining  
4 cases in the docket. However, I want to go forth with  
5 those two compulsory cases, get them out of the way, and  
6 then everything else will fall in line. For example, we  
7 hear 14383, 14384. After that we hear case -- the one on  
8 page 3, Case Number 14362, 14363, and then follow down on  
9 page 6, page 7 and page 8. Any hardships at this time?  
10 Okay.
