- The Hasties #18 was subject to Vandalism. The Wire/Electrical Box/Motor were pilfered - We shall be digging a trench to bury the electrical line
- The Hastie #20 required that the pump jack be moved over the well head, it is now producing gas.
- BLM personnel has given instruction on the placement of Seals on the Storage battery tanks. CDM/FV has implemented the procedures and the seals serial numbers are recorded on the monthly reports.
- Accounting for gas/oil production will be reflected in August 2008 OCD/BLM MMS reports.
