My question is can you put the plugging of the wells on "hold" until I am able to meet with the Commission next week?

The Order is for wells that were not producing...some of the wells you want to Plug are Producing and have been producing for the last 10 years and other was put into production in 2008 in full compliance after the Order was issused. You going plugging some perfect good wells that met the guidelines of the Order you are referring to.

The adminstrative filings C-115 filings do not reflect the actual production and I can show you why they were incorrectly entered -this is a clerical error and can be rectifed with actual proof and revised filings. We are trying to revise the C-115 electronical filing now, but cannot get them entered into the State system - I informed you via email of this last week. My evidence packet will include actual records. Reliance on electrical filings you have would be to ignore the real facts.

Briefly, the DCP has two wells on one meter. We can differenitate the production.

I will be submitting clear and convincing evidence that will Prove beyond any reasonable doubt that some of the Wells that your are plugging are currently producing commercial quantities of oil and gas.

Futhermore, I submit to you, that since the BLM issused the extention of time on March 23th, before your March 26th Plugging appproval that it [BLM March 23th Extention] has precedence over your permit. combined with the fact that the wells are ACTUALLY producing, this matter should be resolved before the Commission and not summarily without a full review of the facts and evidence.

The expenses that we are about to incur may be prevented or substantially mitigated.

I am requesting that you 'hold' the any further plugging for 4 working days.

There are not any environmental nor safety issues or impending matters that will cause damage nor injury to person nor property.

The issue becomes moot if you allow the OCD plugging crew to rush and plug the wells before the April 9th hearing.

I don't think is asking that much under the circumstances.

They have already plugged the State Schneider Well and we learned of it only after a posting on the OCD internet site.

Some of the Wells that your are plugging are producing commerical quantities of oil and gas.

I am willing to abid by the Commissions determination after a review of the facts -
