### APPLICATION

Comes now Marshall & Winston, Inc. by its attorneys, Kellahin & Kellahin, applies to the New Mexico Oil Conservation Division ("Division") for an order canceling the Division's approval of the following for permit to drill ("APD") issued to Yates Petroleum Corporation: API 30-005-29094 for the Derbi DOB Com #1H Well, a horizontal wellbore with a surface location in Unit P and a bottom-hole location in Unit M of Section 9, T15S, R31E, Chaves County and to be dedicated to a non-standard 160-acre spacing unit consisting of the S/2S/2 of this section.

In support of its application, Marshall & Winston, Inc. states:

1. On May 4, 2009, Yates obtained an approved application for permit to drill ("APD") from the Bureau of Land Management-Roswell for the Derbi DOB Com #1H Well, (API # 30-005-29094) a horizontal wellbore with a surface location in Unit P and a bottom-hole location in Unit M of Section 9, T15S, R31E, Chaves County and to be dedicated to a non-standard 160-acre spacing unit consisting of the S/2S/2 of this section. See first page of APD and Division form C-102 attached as Exhibit "A" and "B"

2. On May 8, 2009, the New Mexico Oil Conservation Division, Hobbs, received this BLM approved APD

3. In order to obtain the BLM's approval, Yates filed Division Form C-102 signed by Cy Cowan, as regulatory agent for Yates, certifying that Yates has an interest the bottom-hole location for this wellbore.

4. In doing so, Yates has violated the Division Rules and Orders and has improperly certified Yates does not have any interest in two of the 40-acre tracts interest.

5. Contrary to the certification, Yates does not have an interest in (a) the bottom-hole location or (b) in any portion of the producing interval of this wellbore within the S/2SW/4 of Section 9 nor has it not reached a voluntary agreement with Marshall & Winston or obtained a Division compulsory pooling order. 6. Yates' proposed 160-acre non-standard oil spacing unit each contains four 40-acre tracts consisting of S/2S/2: (See Yates' Form C-102 attached as Exhibit "B")


