


Ladies and gentlemen:

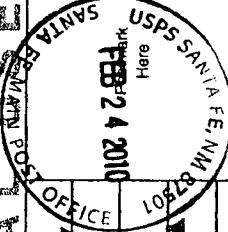

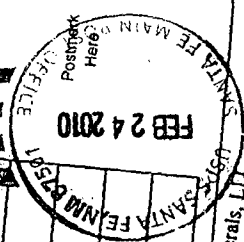

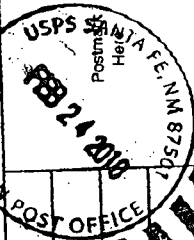
