IN THE MATTER OF THE APPLICATION OF COG OPERATING LLC FOR COMPULSORY POOLING EDDY COUNTY, NEW MEXICO

APPLICATION

COG Operating LLC by its undersigned attorneys, Montgomery & Andrews, P.A. (J. Scott Hall) hereby makes application pursuant to NMSA 1978 Section 70-2-17 (1995) for an order pooling all interests in all formations developed on a 40-acre basis, including the Blinebry and Paddock members of the Glorieta-Yeso formation, underlying the SW/4 SE/4 of Section 2, Township 17 South, Range 30 East, NMPM, Eddy County, New Mexico, to form a standard 40-acre spacing and proration unit. Applicant would show the Division:

- 1. Applicant owns certain working interests in and under the SW/4 SE/4 of Section 2, and has the right to drill thereon.
- 2. Applicant proposes to dedicate the above-referenced pooled unit to its Yale State No. 5 Well to be drilled from a standard location 330' from the South line and 2310' from the East line to a depth sufficient to test the Blinebry and Paddock members of the Glorieta-Yeso formation underlying the SW/4 SE/4 of Section 2, Township 17 South, Range 30 East, NMPM, Eddy County, New Mexico.
- 3. Applicant has been unable to obtain leases or voluntary agreement for pooling or farmout from certain other interest owners in the above-referenced formations underlying the SW/4 SE/4 of said Section 2.

4. In order to permit the Applicant to obtain its just and fair share of the oil and gas

underlying the subject lands, the mineral interests should be pooled and Applicant should be

designated operator of the well.

5. The pooling of interests will afford the Applicant the opportunity to produce its

just and equitable share of hydrocarbons underlying the spacing unit, will avoid the drilling of

unnecessary wells, will prevent waste and will protect correlative rights.

WHEREFORE Applicant requests that this Application be set for hearing before a duly

appointed examiner of the Oil Conservation Division on April 1, 2010 and that after notice and

hearing as required by law, the Division enter its Order pooling the lands and designating

Applicant as operator of the well, including provisions for Applicant to recover its costs of

drilling, equipping and completing the well, its costs of supervision while drilling and after

completion, including overhead charges and providing for adjustments to such rates in

accordance with accepted COPAS accounting procedures, and imposing a 200% risk factor for

the risk assumed by the Applicant in drilling, completing and equipping the well, and making

such other and further provisions as maybe proper in the premises.

Case No. 14449; Application of COG Operating LLC for compulsory pooling, Eddy County, New Mexico. Applicant seeks an order pooling all mineral interests underlying the SW/4 SE/4 of Section 2, Township APT-South, Range 30 East, NMPM, Eddy County, New Mexico, to form standard 40-acre spacing units for any and all formations and or pools developed on 40-acres, including but not necessarily limited to the Blinebry and Paddock members of the Glorieta-Yeso formation. Said units are to be dedicated to Applicant's proposed Yale State No. 5 Well to be drilled at a standard location 330' from the South line and 2310' from the East line of Section 2. Also to be considered will be the cost of drilling and completing said well and the allocation of the cost thereof as well as actual operating costs and charges for supervision, designation of COG Operating LLC as operator of the well and a charge for risk involved in drilling the well. The proposed well location is approximately 9 miles northeast of Loco Hills, New Mexico.
