MOTION TO QUASH SUBPOENA

Agua Sucia, LLC ("Agua Sucia") moves to quash the subpoenas issued to Louis Edgett c/o Agua Sucia, LLC, and in support thereof, states:

1. Armstrong Energy Corporation ("Armstrong") has obtained subpoenas directed to Louis Edgett, c/o Agua Sucia. **Exhibit A.**
2. The letter to the Division requesting the subpoenas states that Armstrong is "proceeding under Rule 4 of the New Mexico Rules of Civil Procedure to serve him at his place of business." **Exhibit B.**
3. While Armstrong may attempt to personally serve Mr. Edgett at his workplace, Rule 4 does not authorize Armstrong to serve Mr. Edgett by merely leaving a subpoena at his workplace or "care of" Agua Sucia's registered agent: Rule 4 is limited to service of a summons (*i.e.* process) pertaining to initiation of a legal action. **SCRA 1-004.** Rule 4 is inapplicable to service of a subpoena.
4. Rule 45 concerns service of a subpoena, and it requires personal service upon a witness, not service of a witness "care of" an employer. **SCRA 1-045.B.**
5. As a result, the subpoenas have been improvidently issued by the Division.

WHEREFORE, Agua Sucia requests that the Division quash the subpoenas attached hereto as Exhibit A.

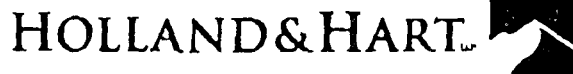
