As indicated on Armstrong's Pre-Hearing Statement, we plan to call Bruce Stubbs, Reservoir Engineer, and Jerry Guy and Gary Wink to testify as fact witnesses. We have subpoenaed Louis Edgett of Agua Sucia, and previously Louray, to testify and, depending on his testimony, we may call Bob Armstrong. I share Jim Bruce's concern about getting this case to hearing but we cannot present our case in 30 minutes and our cross examination may well equal in length our direct case. We therefore cannot present our case in the time available on March 4th. Armstrong can be available on March 18th. If that date does not work for Agua Sucia, we will try to work out a special hearing date for this case if that is the Division's desire.
