ORDER OF THE COMMISSION

(1) By Order Nos. R-13154-B, R-13155-A and R-13182 entered on October 13, 2009, the de novo applications filed in Cases 14365 and 14366 on September 4, 2009 and in Case 14323 on October 9, 2009 were consolidated with Case 14382, originally scheduled for hearing by an examiner and remanded to the Commission.

(2) All four subject cases were scheduled for hearing before the Commission on December 16, 2009. Having been continued for a number of times, the cases are now scheduled to be heard by the Commission on July 15, 2010.

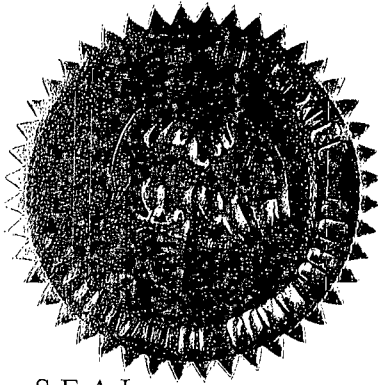
(3) On July 14, 2010, counsel for COG Operating LLC and counsel for Chesapeake Energy Corporation requested that their cases be dismissed. They advised the Commission that all parties of record in these cases are in agreement with the requests for dismissal.

(4) De novo Cases 14323, 14365 and 14366 and Case 14382 should be dismissed.

IT IS THEREFORE ORDERED THAT:

- (1) De novo Case 14323 is hereby dismissed and Order No. R-13154-A is hereby continued in full force and effect until further notice.
- (2) De novo Cases 14365 and 14366 are hereby dismissed and Order No. R-13155 is hereby continued in full force and effect until further notice.
- (3) Case 14382 is hereby dismissed.
