Section 7: Lots 1-4, E $\frac{1}{2}$ W $\frac{1}{2}$, and NE $\frac{1}{4}$


Section 18: Lots 1-4, E $\frac{1}{2}$ W $\frac{1}{2}$, and E $\frac{1}{2}$ (All)
