MOTION FOR CONTINUANCE

Mewbourne Oil Company ("Mewbourne") hereby moves the Oil Conservation Commission for an order continuing the above referenced cases to the November 4, 2010 examiner hearing docket and in support of its motion states:

1. Mewbourne has acquired working interest in Section 10, Township 36 South, Range 33 East and in Section 21, Township 26 South, Range 32 East, NMPM, Lea County, New Mexico.
2. Mewbourne is staking and permitting a well to be drilled as a horizontal well on a project area comprised of the W/2 E/2 of said Section 10 and another well to be drilled as a horizontal well on a project area comprised of the S/2 N/2 of said Section 21.
3. The wells proposed by Mewbourne will be owned 100% before payout by Mewbourne Oil Company.

STATEMENT OF CASE

Mewbourne Oil Company objects to each of the applications of RSC Limited partnership in the above-referenced cases. Mewbourne has acquired working interest in Section 10, Township 36 South, Range 33 East and in Section 21, Township 26 South, Range 32 East, NMPM, Lea County, New Mexico. Mewbourne is staking and permitting a well to be drilled as a horizontal well on a project area comprised of the W/2 E/2 of said Section 10 and another well to be drilled as a horizontal well on a project area comprised of the S/2 N/2 of said Section 21. The wells proposed by Mewbourne will be owned 100% before payout by Mewbourne Oil Company. RSC Resources Limited Partnership seeks orders in each of the above-referenced cases creating non-standard units and pooling tracts for other wells that include the W/2 E/2 of said Section 10 and S/2 N/2 of said Section 21 and in each case seeks an order pooling interests owned by Mewbourne.




