Applicant seeks an order approving the injection and storage and withdrawal of natural gas in the Grama Ridge Storage Area by and through the following wells:

- A. Grama Ridge Morrow Unit Well No. 001 (API No. 30-025-21336) located 1980 feet from the North line and 660 feet from the West line (Unit E) of Section3, Township 22 South, Range 34 East, NMPM;
- B. Grama Ridge Morrow Unit Well No. 002 (API No. 30-025-21717) located 1980 feet from the South line and 660 feet from the West line (Unit L) of Section 34, Township 21 South, Range 34 East, NMPM;
