1 EXAMINER EZEANYIM: This hearing will come  
2 to order. Good morning, ladies and gentlemen. Since we  
3 have a new court reporter, I need to introduce myself  
4 again. My name is Richard Ezeanyim. I am the Hearing  
5 Examiner today. And by my left is David Brooks who will  
6 be the Legal Examiner.

7 Today is February 17th, and it's approximately  
8 8:15 in the morning. And we are going to consider  
9 docket number 5-11.

10 The first order of business today is, first of  
11 all, see which cases are continued or dismissed. And we  
12 go to page 1. Case number 14595 is continued to  
13 March 3; case number ~~14596~~ is continued to March 3. On  
14 page 2, case number 14329 is dismissed. I would like  
15 the counsel to write me a dismissal letter to ensure  
16 that this case is dismissed.

17 Case number 14600 is continued to March 17; case  
18 number 14566 is continued to March 17 on page 3; case  
19 number 14524 is continued to March 17; case number 14551  
20 is continued to March 3.

21 Are there any other continuances or dismissals at  
22 this point?

23 MS. MUNDS-DRY: Mr. Examiner, not  
24 necessarily a continuance or dismissal. I just wanted  
25 to make sure I understand what you said about case

1 number 14329. You had indicated it was dismissed. I  
2 just wanted to make sure it was clear that an amended  
3 order was issued in that case.

4 EXAMINER EZEANYIM: Yes. An amended order  
5 had been issued.

6 MS. MUNDS-DRY: Thank you.

7 EXAMINER EZEANYIM: It needs to be  
8 dismissed, but we need a letter saying that it's  
9 dismissed. Are you the counsel for that?

10 MS. MUNDS-DRY: Yes.

11 EXAMINER EZEANYIM: Okay. Get me a letter  
12 for that.

13 MS. MUNDS-DRY: Okay. I'd be happy to.  
14 Thank you.




