APPLICATION OF MEWBOURNE OIL COMPANY FOR A NON-STANDARD SPACING AND PRORATION UNIT, UNORTHODOX WELL LOCATION AND COMPULSORY POOLING, EDDY COUNTY, NEW MEXICO.

ORDER OF THE DIVISION

BY THE DIVISION:

This case came on for hearing at 8:15 a.m. on March 3, 2011 at Santa Fe, New Mexico, before Examiner David K. Brooks.

NOW, on this 9th day of March, 2011, the Division Director, having considered the testimony, the record and the recommendations of the Examiner,

FINDS THAT:

- (1) Due public notice has been given, and the Division has jurisdiction of this case and of the subject matter.
- (2) Mewbourne Oil Company ("Applicant"), seeks approval of a non-standard 120-acre oil spacing and proration unit and project area ("the Unit") in the Yeso formation (North Seven Rivers-Glorieta-Yeso Pool [Pool Code 97565]) consisting of the E/2 NW/4 and NE/4 SW/4 (Units C, F and K) of Section 24, Township 19 South, Range 25 East, NMPM, in Eddy County, New Mexico. Applicant further seeks an order pooling all uncommitted interests in the Unit in the Yeso formation.
- (3) The Unit is to be dedicated to Applicant's Wyatt Draw KC Well No. 1H ("the proposed well"), a horizontal well to be drilled from a standard surface location 990 feet from the South line and 1650 feet from the West line (Unit N) of Section 24. The well will penetrate the top of the North Seven-Rivers-Glorieta-Yeso Pool at a non-standard oil well location approximately 1290 feet from the South line and 1650 feet from the West line (Unit N) of Section 24 and continue horizontally in the Yeso to a

standard terminus, or bottomhole location, 330 feet from the North line and 1650 feet from the West line (Unit C) of Section 24.

- (4) Spacing in the North Seven Rivers-Glorieta-Yeso Pool is governed by statewide Rule 15.9.A, which provides for standard 40-acre units, each comprising a governmental quarter-quarter section, with wells to be located at least 330 feet from any unit boundary. The Unit consists of three adjacent quarter-quarter sections. The location is unorthodox at the point of penetration since it is less than 330 feet from the southern boundary of the proposed project area.
- (5) Applicant appeared at the hearing through counsel and presented geologic evidence to the effect that:
 - (a) this area is suitable for development by horizontal drilling; and
 - (b) all quarter-quarter sections to be included in the Unit are expected to be productive in the Yeso, so that formation of the Unit as requested will not impair correlative rights.
- (6) No other party appeared at the hearing, or otherwise opposed the granting of this application.

The Division concludes that:

- (7) Approval of the proposed non-standard unit will enable Applicant to drill a horizontal well that will efficiently produce the reserves underlying the Unit, thereby preventing waste, and will not impair correlative rights.
- (8) Approval of the unorthodox location of the proposed well will enable Applicant to efficiently drain reserves in the target formation within the Unit, thereby preventing waste, and will not impair correlative rights.
- (9) Two or more separately owned tracts are embraced within the Unit, and/or there are royalty interests and/or undivided interests in oil and gas minerals in one or more tracts included in the Unit that are separately owned.
- (10) Applicant is an owner of an oil and gas working interest within the Unit. Applicant has the right to drill and proposes to drill the proposed well to a common source of supply within the Unit at the proposed location.
- (11) There are interest owners in the Unit that have not agreed to pool their interests. There are no unlocated owners in the Unit.
- (12) To avoid the drilling of unnecessary wells, protect correlative rights, prevent waste and afford to the owner of each interest in the Unit the opportunity to recover or receive without unnecessary expense its just and fair share of hydrocarbons,

this application should be approved by pooling all uncommitted interests, whatever they may be, in the oil and gas within the Unit.

- (13) Mewbourne Oil Company should be designated the operator of the proposed well and of the Unit.
- (14) Any pooled working interest owner who does not pay its share of estimated well costs should have withheld from production its share of reasonable well costs plus an additional 200% thereof as a reasonable charge for the risk involved in drilling the well.
- (15) Reasonable charges for supervision (combined fixed rates) should be fixed at \$6,000 per month while drilling and \$600 per month while producing, provided that these rates should be adjusted annually pursuant to Section III.1.A.3. of the COPAS form titled "Accounting Procedure-Joint Operations."

IT IS THEREFORE ORDERED THAT:


- (1) A non-standard 120-acre oil spacing and proration unit (the Unit) is hereby established in the Yeso formation (North Seven Rivers-Glorieta-Yeso Pool [Pool Code 97565]) consisting of the E/2 NW/4 and NE/4 SW/4 (Units C, F and K) of Section 24, Township 19 South, Range 25 East, NMPM, in Eddy County, New Mexico.
- (2) Pursuant to the application of Mewbourne Oil Company, all uncommitted interests, whatever they may be, in the oil and gas in the Yeso formation underlying the Unit, are hereby pooled.
- (3) The Unit shall be dedicated to Applicant's Wyatt Draw KC Well No. 1H ("the proposed well"), a horizontal well to be drilled from a standard surface location 990 feet from the South line and 1650 feet from the West line (Unit N) of Section 24. The well will penetrate the top of the North Seven Rivers-Glorieta-Yeso Pool at a non-standard oil well location approximately 1290 feet from the South line and 1650 feet from the West line (Unit N) of Section 24 and continue horizontally in the Yeso to a standard terminus, or bottomhole location, 330 feet from the North line and 1650 feet from the West line (Unit C) of Section 24.
- (4) The unorthodox location of the proposed well, as described in Ordering Paragraph (3), is hereby approved.
- (5) The operator of the Unit shall commence drilling the proposed well on or before March 15, 2012, and shall thereafter continue drilling the well with due diligence to test the Yeso formation.
- (6) In the event the operator does not commence drilling the proposed well on or before March 15, 2012, Ordering Paragraphs (1) and (2) shall be of no effect, unless

the operator obtains a time extension from the Division Director for good cause demonstrated by satisfactory evidence.

- (7) Should the proposed well not be drilled and completed within 120 days after commencement thereof, then Ordering Paragraphs (1) and (2) shall be of no further effect, and the unit and project area created by this order shall terminate, unless operator appears before the Division Director and obtains an extension of the time for completion of the proposed well for good cause shown by satisfactory evidence. If the proposed well is not completed in all of the quarter-quarter sections included in the proposed unit within 120 days after commencement of drilling, then the operator shall apply to the Division for an amendment to this Order to contract the Unit so that it includes only those quarter-quarter sections in which the well is completed.
- (8) Upon final plugging and abandonment of the proposed well and any other well drilled on the Unit pursuant to Division Rule 13.9, the pooled unit created by this Order shall terminate, unless this order has been amended to authorize further operations.
- (9) Mewbourne Oil Company [OGRID 14744] is hereby designated the operator of the well and of the Unit.
- (10) After pooling, uncommitted working interest owners are referred to as pooled working interest owners. ("Pooled working interest owners" are owners of working interests in the Unit, including unleased mineral interests, who are not parties to an operating agreement governing the Unit.) After the effective date of this order, the operator shall furnish the Division and each known pooled working interest owner in the Unit an itemized schedule of estimated costs of drilling, completing and equipping the proposed well ("well costs").
- (11) Within 30 days from the date the schedule of estimated well costs is furnished, any pooled working interest owner shall have the right to pay its share of estimated well costs to the operator in lieu of paying its share of reasonable well costs out of production as hereinafter provided, and any such owner who pays its share of estimated well costs as provided above shall remain liable for operating costs but shall not be liable for risk charges. Pooled working interest owners who elect not to pay their share of estimated well costs as provided in this paragraph shall thereafter be referred to as "non-consenting working interest owners."
- (12) The operator shall furnish the Division and each known pooled working interest owner (including non-consenting working interest owners) an itemized schedule of actual well costs within 90 days following completion of the proposed well. If no objection to the actual well costs is received by the Division, and the Division has not objected, within 45 days following receipt of the schedule, the actual well costs shall be deemed to be the reasonable well costs. If there is an objection to actual well costs within the 45-day period, the Division will determine reasonable well costs after public notice and hearing.

- (13) Within 60 days following determination of reasonable well costs, any pooled working interest owner who has paid its share of estimated costs in advance as provided above shall pay to the operator its share of the amount that reasonable well costs exceed estimated well costs and shall receive from the operator the amount, if any, that the estimated well costs it has paid exceed its share of reasonable well costs.
- (14) The operator is hereby authorized to withhold the following costs and charges from production:
 - (a) the proportionate share of reasonable well costs attributable to each non-consenting working interest owner; and
 - (b) as a charge for the risk involved in drilling the well, 200% of the above costs.
- (15) The operator shall distribute the costs and charges withheld from production, proportionately, to the parties who advanced the well costs.
- (16) Reasonable charges for supervision (combined fixed rates) are hereby fixed at \$6,000 per month while drilling and \$600 per month while producing, provided that these rates shall be adjusted annually pursuant to Section III.1.A.3. of the COPAS form titled "Accounting Procedure-Joint Operations." The operator is authorized to withhold from production the proportionate share of both the supervision charges and the actual expenditures required for operating the well, not in excess of what are reasonable, attributable to pooled working interest owners.
- (17) Any unleased mineral interest shall be considered a seven-eighths (7/8) working interest and a one-eighth (1/8) royalty interest for the purpose of allocating costs and charges under this order. Any well costs or charges that are to be paid out of production shall be withheld only from the working interests' share of production, and no costs or charges shall be withheld from production attributable to royalty interests.
- (18) Should all the parties to this compulsory pooling order reach voluntary agreement subsequent to entry of this order, this order shall thereafter be of no further effect.
- (19) The operator of the well and Unit shall notify the Division in writing of the subsequent voluntary agreement of all parties subject to the forced pooling provisions of this order.
- (20) Jurisdiction of this case is retained for the entry of such further orders as the Division may deem necessary.
