

APPLICATION

Mewbourne Oil Company applies for approval of an unorthodox oil well location in the NW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 17, Township 18 South, Range 32 East, N.M.P.M., Eddy County, New Mexico, and in support thereof, states:


1. Applicant is a working interest owner in the NW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 17, and has the right to drill a well thereon.

2. Applicant proposes to drill its SF "17" Fed. Com. Well No. 2 at an unorthodox oil well location 1910 feet from the south line and 1370 feet from the east line of Section 17, to a depth sufficient to test the Wolfcamp formation (Undesignated Young-Wolfcamp Pool) and Strawn formation (Undesignated Young-Strawn Pool). The NW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 17 will be dedicated to the well in both formations.

3. Approval of the unorthodox location will prevent waste and protect correlative rights.

WHEREFORE, Applicant requests that, after notice and hearing, the Division enter its order approving the above location.

Well No. 2 at an unorthodox oil well location 1910 feet from the south line and 1370 feet from the east line of Section 17, Township 18 South, Range 32 East, N.M.P.M., in the Wolfcamp formation (Undesignated Young-Wolfcamp Pool) and Strawn formation (Undesignated Young-Strawn Pool).
