STATEMENT OF THE CASE

Mewbourne Oil Company seeks an order creating a non-standard spacing unit comprised of the E/2 W/2 of Section 6 Township 20 South, Range 29 East, NMPM, and pooling all mineral interests in the Bone Spring formation, Winchester Bone Spring Pool, in this non-standard spacing and proration unit which spacing unit will be the project area for the Ruger "6" Federal Com No. 5-H Well (API No. 30-015-37199) which it proposes to drill as a horizontal oil well from a non-standard surface location 150 feet from the North line and 1400 feet from the West line of said Section 6, and then in a southerly direction in the third sand interval of the Bone Spring formation to a bottom hole terminus at a point 330 feet the South line and 1400 feet from the West line of said Section 6. This well will penetrate the Bone Spring formation at an unorthodox location 150 feet from the North line and 1400 feet from the East line of Section 6, however, the producing interval in the wellbore is within the well's "producing area." Also to be considered will be the cost of drilling and completing the well and the allocation of the costs thereof as well as actual operating costs and charges for supervision, designation of Mewbourne Oil Company as operator of the well and a charge for risk involved in drilling said well.
