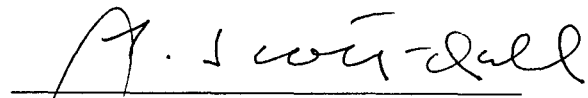

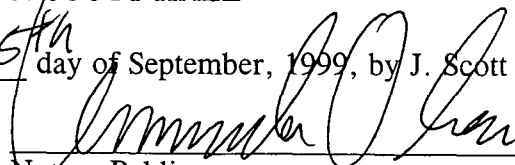

Dear Sir or Madam:

Please be advised that Energen Resources Corporation has filed an Application with the New Mexico Oil Conservation Division (NMOCD) seeking the issuance of an order (1) temporarily reducing the production allowable for wells in the West Lovington Strawn Pool to the minimum level which will avoid the termination of leases for the failure to produce in paying quantities, and (2) requiring the operator of the West Lovington Strawn Unit to escrow production payments from wells it operates adjacent to the Unit. Energen will also seek authorization to produce and escrow production proceeds for its Beadle No. 1 well to be drilled to the Strawn formation in the W/2 SW/4 of Section 35, T-15-S, R-35-E, NMPM for an appropriate period of time preparatory to the inclusion of the well in the West Lovington Strawn Unit.

Energen's Application, originally filed with the New Mexico Oil Conservation Commission, was consolidated with a substantially similar Application filed before the NMOCD on behalf of Yates Petroleum Corporation and Hanley Petroleum, Inc. The consolidated proceeding has been set for hearing before a Division Examiner at 8:15 a.m. on Thursday, September 16, 1999 at the NMOCD's office at 2040 South Pacheco Street in Santa Fe, New Mexico. You are not required to attend this hearing, but as an operator of a well, a mineral lessee or the owner of an unleased mineral interest, you have the right to appear and participate in the hearing. Failure to appear at that time and become a party of record will preclude you from challenging this matter at a later date.
