

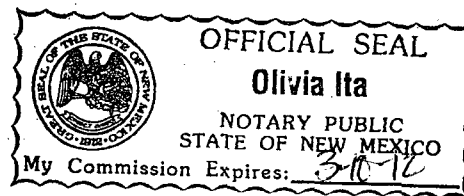

Re: Application of Mewbourne Oil Company for a non-standard spacing and proration unit, unorthodox well location, and compulsory pooling, Eddy County, New Mexico.


Ladies and Gentlemen:

This letter is to advise you that Mewbourne Oil Company has filed the enclosed application with the New Mexico Oil Conservation Division seeking an order (1) creating a non-standard spacing unit comprised of the W/2 E/2 of Section 6, Township 20 South, Range 29 East, NMPM, and (2) pooling all mineral interests in the Bone Spring formation, in this non-standard spacing and proration unit which spacing unit will be the project area for its proposed Ruger "6" Federal Com No. 4H Well (API No. 30-015-37198) to be horizontally drilled from a surface location 150 feet from the North line and 1755 feet from the East line of said Section 6 and then in a southerly direction in the third sand interval of the Bone Spring formation, to a bottom hole terminus at a location 330 feet from the South line and 2130 feet from the East line of said Section 6. This well will penetrate the Bone Spring formation at an unorthodox location 150 feet from the North line and 1755 feet from the East line of Section 6, however, the producing interval in the wellbore is within the well's "producing area."

This application has been set for hearing before a Division Examiner at 8:15 AM on March 31, 2011. The hearing will be held in Porter Hall in the Oil Conservation Division's Santa Fe Offices located at 1220 South Saint Francis Drive, Santa Fe, New Mexico 87505. You are not required to attend this hearing, but as an owner of an interest that may be affected by this application, you may appear and present testimony. Failure to appear at that time and become a party of record will preclude you from challenging the matter at a later date.

Parties appearing in cases are required by Division Rule 1208.B to file a Pre-Hearing Statement with the Oil Conservation Division's Santa Fe office, four days in advance of a scheduled hearing, but at least on the Thursday preceding the hearing. This statement must include: the names of the parties and their attorneys; a concise statement of the case; the names of all witnesses the party will call to testify at the hearing; the approximate time the party will need to present its case; and identification of any procedural matters that are to be resolved prior to the hearing.
