Poker Lake Unit #325H Eddy County, New Mexico - This well will be drilled at a legal location being 2250' FNL & 940' FWL, Section 22, T24S-R30E, Eddy County, New Mexico to a proposed depth of 7,555' to test the Delaware Formation.

Poker Lake Unit #326H Eddy County, New Mexico - This well will be drilled at a legal location being 200' FSL & 1025' FEL, Section 22, T24S-R30E, Eddy County, New Mexico to a proposed depth of 7,677' to test the Delaware Formation.

Poker Lake Unit #327H Eddy County, New Mexico - This well will be drilled at a legal location being 1400' FNL & 635' FWL, Section, T24S-R30E, Eddy County, New Mexico to a proposed depth of 7,840' to test the Delaware Formation.

Poker Lake Unit #328H Eddy County, New Mexico - This well will be drilled at a legal location being 2400' FSL & 305' FWL, Section 12, T24S-R30E, Eddy County, New Mexico to a proposed depth of 7,784' to test the Delaware Formation.
