CASE No. 14645:

Application of Mewbourne Oil Company for a non-standard spacing and proration unit unorthodox well location, and compulsory pooling, Eddy County, New Mexico. Applicant in the above-styled cause seeks an order creating a non-standard spacing unit comprised of the SE/4 SW/4 of Section 24 and the E/2 NW/4 of Section 25, Township 19 South, Range 25 East, NMPM, which will be the horizontal well project area for the Wyatt Draw "24/25" NF Federal Com No. 1H Well to be horizontally drilled from a surface location 1650 feet from the South line and 2290 feet from the West line of Section 24 and then in a southerly direction in the Yeso formation, to a bottom hole terminus at a location 2310 feet from the North line and 2290 feet from the West line of Section 25, both in Township 19 South, Range 25 East, (2) approving an unorthodox well location in the Yeso formation, and (2) pooling all mineral interests in the Yeso formation, North Seven Rivers, Glorieta, Yeso Pool, in this non-standard spacing and proration unit - horizontal well project area. The producing interval in the wellbore is within the well's "producing area." Also to be considered will be the cost of drilling and completing said well and the allocation of the cost thereof as well as actual operating costs and charges for supervision, designation of Mewbourne Oil Company as operator of the well and a charge for risk involved in drilling said well. Said area is located approximately 6 miles north of Lakewood, New Mexico.
