




To Whom it May Concern:

This letter is to advise you that Texaco Exploration and Production Inc. has filed the enclosed application with the New Mexico Oil Conservation Division seeking authority to downhole commingle production from the Blinebry formation, Justis Blinebry Pool and the Tubb-Drinkard formation, Justis Tubb-Drinkard Pool, in the wellbore of all wells in a Redevelopment Area comprised of portions of Sections 26 and 35, Township 24 South, Range 37 East and Section 2, Township 25 South, Range 37 East, N.M.P.M., Lea County, New Mexico.

This case has been set for hearing before a Division Examiner on May 4, 1995. You are not required to attend this hearing, but as an offsetting operator who may be affected by this application, you may appear and present testimony. Failure to appear at the time of the hearing will preclude you from challenging the matter at a later date.

Parties appearing in cases have been requested by the Division (Memorandum 2-90) to file a Prehearing Statement substantially in the form prescribed by the Division. Prehearing statements should be filed by 4:00 o'clock p.m. on the Friday before a scheduled hearing.
