

CASE 10286: In the matter of the hearing called by the Oil Conservation Division upon its own motion for an order creating and extending certain pools in Eddy County, New Mexico.

- (a) CREATE a new pool in Eddy County, New Mexico, classified as a gas pool for Bone Spring production and designated as the West Magruder-Bone Spring Gas Pool. The discovery well is the Yates Petroleum Corporation South Avalon "MA" Federal Com. Well No. 1 located in Unit I of Section 14, Township 21 South, Range 26 East, NMPM. Said pool would comprise:
