Gentlemen:

This letter is to advise you that Texaco Exploration and Production Inc. has filed an application with the New Mexico Oil Conservation Division seeking approval to re-enter and horizontally drill its Jicarilla "C" Well No. 35 located in the S/2 of Section 21, Township 25 North, Range 5 West, N.M.P.M., in the West Lindrith Gallup-Dakota Oil Pool. The Jicarilla "C" Well No. 35 is located at a standard location 1850 feet from the South line and 1190 feet from the West line of Section 21. Texaco plans to re-enter this well and kick-off from vertical in an easterly direction commencing to build angle at an appropriate rate to horizontally traverse the proposed producing interval.

This application has been set for hearing before an Examiner of the Oil Conservation Division on August 24, 1995. You are not required to attend this hearing, but as an owner of an interest that may be affected by this application, you may appear at the hearing and present testimony. Failure to appear at that time and become a party of record will preclude you from challenging this matter at a later date.

Parties appearing in cases have been requested by the Division (Memorandum 2-90) to file a Pre-Hearing statement substantially in the form prescribed by the Division. Pre-Hearing statements should be filed by 4:00 o'clock p.m. on the Friday before a scheduled hearing. If you have no objection to Texaco's application, please sign the waiver at the bottom of this letter and return same to my attention at the letterhead address. Your prompt attention to this matter is greatly appreciated.
