3           EXAMINER STOGNER: At this time I'm going to call  
4 Case Number 11,332, which is the Application of Yates  
5 Petroleum Corporation to rescind Division Order Number  
6 R-10,372, Eddy County, New Mexico.

7           This particular request is to rescind said order,  
8 which was dated May 24th, 1995, issued for the  
9 authorization of Yates Petroleum to drill its Aspden "AOH"  
10 Federal Com Well Number 2 in an unorthodox location 330  
11 from the south line and 1980 from the west line.

12           This is a request, in the absence of objection,  
13 to take under advisement.

14           Also, there's a twin case, 11,357, which I'll  
15 call at this time, which is the Application of Yates  
16 Petroleum Corporation for directional drilling and  
17 simultaneous dedication in Eddy County, New Mexico.

18           This particular Application is to directionally  
19 drill said Aspden "AOH" Federal Com Well Number 2 to bottom  
20 in a standard location in the North Dagger Draw-Upper  
21 Pennsylvanian Pool.

22           This particular Application was put on the docket  
23 today. It was originally filed administratively, but an  
24 objection was received in this matter and it was put on the  
25 docket.

1           Since then, I've had some correspondence which is  
2 waiving objection by Conoco in these two matters.

3           But for procedural sake, I will call both of  
4 these cases at this time and ask for any appearances, if  
5 necessary.

6           There being none, Case Number 11,332 will be  
7 taken under advisement. Case Number 11,357 will be  
8 dismissed. This matter will be handled administratively.


