APPLICATION

Comes now CHESAPEAKE OPERATING, INC., by and through its attorneys, KELLAHIN and KELLAHIN, and applies to the New Mexico Oil Conservation Division for approval to drill its Shaw "15" Well No. 2 at an unorthodox oil well location 2100 feet from the North line and 2310 feet from the East line (Unit G) of Section 15, Township 17 South, Range 37 East, NMPM to be dedicated to a standard 80-acre oil spacing and proration unit consisting of the S/2NE/4 of said Section 15.

In support thereof, Applicant states:

1. Applicant, Chesapeake Operating, Inc. has 100% of the working interest in the S/2NE/4 of Section 15, T17S, R37E, NMPM, Lea County, New Mexico.

2. Applicant proposes to locate its Shawn "15" Well No. 2 at an orthodox oil well location 2100 feet from the north line and 2310 feet from the east line of said Section 15 for possible production from the Strawn formation of the Humble City-Strawn Pool.

3. The subject well is within the current boundaries of the Humble City-Strawn Pool which provides for 80-acre oil spacing and proration units and standard well locations within 150 feet of the center of either quarter-quarter section within the spacing unit (Order R-4338, issued June 28, 1972).


4. The unorthodox location is necessary in order to attempt to locate the point of greatest thickness of potential strawn algal mound development within the spacing unit.

5. In accordance with Division notice rules, notification has been sent to the affected parties towards who the well encroaches as set forth on Exhibit "A" attached.

6. Approval of the application will afford the applicant the opportunity to produce its just and equitable share of the hydrocarbons in the Strawn formation and will otherwise prevent waste and protect correlative rights.

WHEREFORE, Applicant requests that, after notice and hearing, this Application be approved as requested.
