Gentlemen:

This letter is to advise you that Yates Petroleum Corporation has filed the enclosed amended application with the New Mexico Oil Conservation Division seeking an order amending the Special Rules and Regulations for the Indian Basin-Upper Pennsylvanian Associated Pool to provide for no more than one well per 80-acres, to allow the simultaneous dedication of acreage to both oil and gas wells, a special limiting gas-oil ratio of 10,000 cubic feet of gas for each barrel of oil produced and a special oil allowable for the pool of 1400 barrels of oil per day.

This application has been set for hearing before a Division Examiner on March 21, 1996. You are not required to attend this hearing, but as an owner of an interest that may be affected by this application, you may appear at the hearing and present testimony. Failure to appear at that time or otherwise become a party of record in this case will preclude you from challenging the matter at a later date.
