

This letter is to advise you that Bonneville Fuels Corporation has filed the enclosed application with the New Mexico Oil Conservation Division seeking an order contracting the boundaries of the South Humble City-Strawn Pool and creating a new pool for production of oil from the Strawn Formation. Bonneville also seeks the promulgation of special rules and regulations for this new pool including provisions for 80-acre spacing units, a special depth bracket allowable and a limiting gas-oil ratio for the pool of 8000 cubic feet of gas for each barrel of oil produced.

This application has been set for hearing before an Examiner of the Oil Conservation Division on May 2, 1996. You are not required to attend this hearing, but as the owner of an interest that may be affected by this application, you may appear at the hearing and present testimony. Failure to appear at that time or otherwise become a party of record in this case will preclude you from challenging this matter at a later date.

Parties appearing in cases before the Division have been requested to file a Pre-Hearing Statement substantially in the form prescribed by the Division (Oil Conservation Division Memorandum 2-90). Pre-hearing Statements should be filed by 4:00 o'clock P.M. on the Friday before a scheduled hearing.
