



The Office of State Purchasing is charged with the responsibility of securing those items and/or services which are necessary for agencies of State Government to serve the public in an efficient, economical and professional manner. To satisfy this responsibility, nearly every conceivable type of professional or general service, product or construction is required.


Prior to completing the "Vendor Registration Application", you are encouraged to take the time to carefully review the Commodity Code Book and to identify the Class and Item Number(s) that describe the products and/or services you can provide to the State of New Mexico. You should register only in those categories which offer you good potential for business and, in the interest of keeping duplicating and mailing costs to a minimum, you are asked to restrict selections to your prime area of business. The right to delete classes and/or groups from a registration form is reserved by this office, if after a determination is made that said items are not in the vendors prime area of business. Should this occur the vendor will be notified of said action.

The Procurement Code requires that a determination be made as to the responsibility of each bidder. To meet this requirement, a potential bidder must furnish information and data to prove financial resources, production or service facilities, service reputation and experience are adequate to make satisfactory delivery of materials or services on which a bid is submitted.

In order to define the cost of processing, reproduction, and mailing costs associated with furnishing you, the bidder, with Invitation for Bids/Request for Proposals and other bid related information, a \$75 annual registration fee must accompany your completed Vendor Registration Form. It is requested the \$75 be either in check or money order, made payable to State Purchasing.


