In the matter of the application of the Oil Conservation Division of the Energy, Minerals and Natural Resources Department upon its own motion for an order for the creation, discovery allowable assignment and extension of certain existing pools in Eddy County, New Mexico, and giving notice to all persons and parties interested in the subject matter thereof, to show cause why such creations, discovery allowable assignment and extensions should not be made.

(a) CREATE a new pool in Eddy County, New Mexico, classified as a gas pool for Morrow production and designated as the Indian Basin; Morrow, East Gas Pool. The discovery well, the Bone Flat "12" Federal Com. #5 completed by Marathon Oil Company, is located in Unit F of Section 12, Township 21 South, Range 23 East, NMPM. Said pool would comprise:

(b) CREATE a new pool in Eddy County, New Mexico, classified as a gas pool for Morrow production and designated as the Red Lake; Morrow Gas Pool.
