1 WHEREUPON, the following proceedings were had at
2 9:22 a.m.:

3 EXAMINER STOGNER: At this time I'm going to
4 consolidate the last three cases on the docket.

5 That's Case 11,582, which is in the matter of the
6 hearing called by the Oil Conservation Division on its own
7 motion for an order creating and extending certain pools in
8 Eddy County, New Mexico. This could be called our
9 nomenclature from District 2, Artesia.

10 Case Number 11,592, which is in the matter of the
11 hearing called by the Oil Conservation Division upon its
12 own motion for an order creating and extending certain
13 pools in Lea County, New Mexico. This could be considered
14 our District 1 nomenclature from Hobbs.

15 And Case Number 11,593, which is in the matter of
16 the hearing called by the Oil Conservation Division upon
17 its own motion for an order creating and extending certain
18 pools in Rio Arriba and San Juan Counties, New Mexico.
19 This can be considered our District 3 Nomenclature out of
20 Aztec.

21 The docket has been prepared to exhibit what each
22 District has proposed to extend and create certain pools in
23 those counties stated, and each has been double-checked to
24 make sure of its accuracy.

25 But at this time I'll call for any appearances in

1 these matters, any of them.

2 There being none, then Cases 11,582, 11,592 and
3 11,593 will be taken under advisement.

4 And with that, the hearing is adjourned.


