MOTION TO CONSOLIDATE AND MOTION TO CONTINUE

COME NOW BASS ENTERPRISES PRODUCTION COMPANY and SANTA FE ENERGY COMPANY, by their attorneys, Losee, Carson, Haas & Carroll, P. A. (James E. Haas and Ernest L. Carroll), and in support hereof, respectfully state:

1. Bass and Santa Fe have made application in Case No. 11713 for the Division to rescind its Order NSL-3745 approving Mewbourne's Application for Unorthodox Well Location for its Scanlon Draw "35" State No. 1 Well at an unorthodox location 660 feet FSL and 1980 feet FWL of Section 35, Township 18 South, Range 28 East, N.M.P.M., Eddy County, New Mexico.

2. Bass filed an Application to Drill and Simultaneous Dedication, or in the Alternative, Unorthodox Location and Simultaneous Dedication for its Turkey Track "2" State No. 2 Well for the E/2 of Section 2, Township 19 South, Range 28 East, N.M.P.M., Eddy County, New Mexico on Friday, February 28, 1997.

3. The evidence and issues in this Case 11713 and the case referred to in paragraph 2 herein are identical, and in the interest of time and economy, Bass seeks to consolidate these two cases.

4. Case 11713 is presently set for the March 20, 1997, docket, and in order to be heard with the more recent application, must be continued.

5. Opposing counsel have been provided with the subject motion and concurrence was requested, however, to date no response has been had.

WHEREFORE, Applicants pray as follows:

A. that the instant Case No. 11713 and the application referred to in paragraph 2 herein be consolidated and considered by the Division concurrently;

B. that this case be continued from the March 20, 1997, docket so that it may be heard concurrently with the more recent application referenced herein.

D. and for such other relief as may be just in the premises.
