NOW, on this 20th day of March, 1997, the Division Director, having considered the record and the recommendations of the Examiner, and being fully advised in the premises,

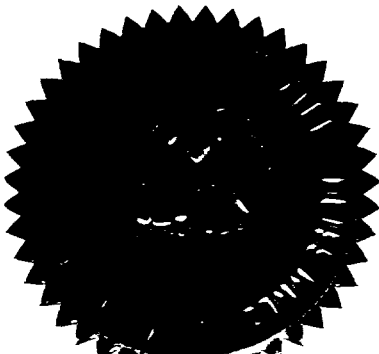
FINDS THAT:


- (1) The subject application was approved administratively by Division Order No. NSP-1769(L) dated March 18, 1997.

IT IS THEREFORE ORDERED THAT:

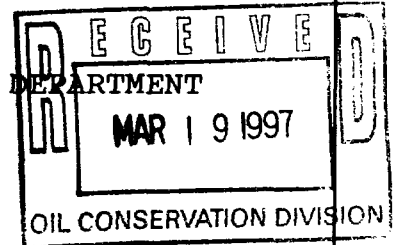
Case No. 11736 is hereby dismissed.


