




Dear Ms Swierc:

This letter is to advise you that Enron Oil and Gas Company has filed the enclosed application with the New Mexico Oil Conservation Division seeking authority to downhole commingle gas production from the Atoka formation, Sand Tank-Atoka Gas Pool, and Morrow formation, Undesignated Sand Tank-Morrow Gas Pool in the wellbore of its Sand Tank "6" Federal No. 1 Well located 1980 feet from the North line and 1650 feet from the East line of Section 6, Township 18 South, Range 30 East, NMPM.

This case has been set for hearing before a Division Examiner on March 20, 1997. 
