

Proposed notification/advertisement for OCD docket

Case 1745: Application of Fasken Oil and Ranch, Ltd. for an unorthodox gas well location and non-standard gas proration and spacing unit, Eddy County, New Mexico. Applicant seeks approval to drill its proposed Avalon "1" Federal Com Well No. 2 at an unorthodox gas well location 750 feet from the West line and 2080 feet from the South line of Irregular Section 1, Township 21 South, Range 25 East, NMPM, to the base of the Morrow formation, said location being unorthodox for any and all gas producing formations from the top of the Wolfcamp to the base of the Morrow, including but not limited to the Catclaw Draw-Morrow Gas Pool, and, if productive, to be dedicated to a non standard 297.88-acre gas spacing unit consisting of Lots 29, 30, 31, 32, and SW/4 (S/2 equivalent) of said Section 1. Said location is located approximately 9 miles northwest from Carlsbad, New Mexico.

APPLICATION

Comes now FASKEN OIL AND RANCH, LTD. ("Fasken") by and through its attorneys, KELLAHIN and KELLAHIN, and applies to the New Mexico Oil Conservation Division ("NMOCD") for an unorthodox gas well location 750 feet from the West line and 2080 feet from the South line of Irregular Section 1, Township 21 South, Range 25 East, NMPM, to the base of the Morrow formation, for its proposed Avalon "1" Federal Com Well No. 2, said location being unorthodox for any and all gas producing formations from the top of the Wolfcamp to the base of the Morrow, including but not limited to the Catclaw Draw-Morrow Gas Pool, and, if productive, to be dedicated to a non standard 297.88-acre gas spacing unit consisting of Lots 29, 30, 31, 32, and SW/4 (S/2 equivalent) of said Section 1.

In support thereof, Applicant states:

1. Applicant, Fasken, is the operator of the southern portion of Irregular Section 1 as a result of a Joint Operating Agreement dated April 1, 1970 which includes Mewbourne Oil Company and Matador Petroleum Corporation as non-operators.

2. Fasken, as operator, proposes to drill the Avalon "1" Federal Com Well No. 2 to be located 1650 feet from the West line and 1650 South line of Irregular Section 1, T21S, R25E, Eddy County, New Mexico. **See Exhibit 1.**

3. Fasken proposes to drill this well to a total depth of 10,650 feet to test for gas production from the Morrow formation and shallower formations.

4. The well location is within one mile of the current boundary of the Catclaw Draw-Morrow Gas Pool which is subject to the Division's Special Rules and Regulations (Order R-4157-D) which include:

"Rule: 2...shall be located no closer than 1650 feet to the outer boundary of the section nor closer than 330 feet to any governmental quarter-quarter section line."

"Rule 5: A standard gas proration unit...shall be 640-acres."

5. While the Catclaw Draw-Morrow Gas Pool is still officially "prorated", prorationing has been suspended and the wells in the pool are allowed to produce at capacity.

6. Fasken proposes to dedicate the southern 297.88 acres of Irregular Section 1 to the well if it is capable of gas production from the top of the Wolfcamp to the base of the Morrow formation.

7. Irregular Section 1 consists of 853.62 acres is divided into thirds with the central portion of this section being "unleased" federal oil and gas minerals the surface of which is subject to a federal environmental study. As a result, applicant requests approval of a non standard 297.88 acre unit comprising the southern portion of Irregular Section 1 described as Lots 29, 20, 31, 32 and the SW/2 (S/2 equivalent).

8. This proposed location is the optimum location in the proposed spacing unit at which to drill to test for Morrow gas production.


9. Approval of this application will afford the applicant the opportunity to produce its just and equitable share of the gas underlying this unit, will prevent the economic loss caused by the drilling of unnecessary wells, avoid the augmentation of risk arising from the drilling of an excessive number of wells and will otherwise prevent waste and protect correlative rights.
