## STATEMENT OF THE CASE

### APPLICANT

Devon Energy Corporation, Applicant in the above-styled cause seeks an order pooling all mineral interests from the surface to the base of the Morrow formation underlying the S/2 of Section 15, T-21-S, R-26-E, for its proposed Carlsbad "15" Federal Com Well No. 1 to be drilled at a standard location 1,980 feet from the south line 1,850 feet from the west line (Unit K) of said Section 15. Also to be considered, will be the costs of drilling and completing said well and the allocation of the costs thereof, as well as actual operating costs and charges for supervision, designation of Operator of the well, and a charge for the risk involved for drilling said well.
